This Fees Notice is intended to provide owners with an estimation of fees and expenses. It does not serve as a fixed price quotation. All fees and charges are invoiced monthly in arrears. It is not possible to indicate in advance the exact total monthly or yearly cost for training a horse. This is due to some fees being charged at a daily rate (training fees, etc.) while others are variable and are charged per treatment (veterinary, farriery, equine therapy, etc.). Horses also vary at the rate in which they mature and progress, throughout each preparation and while on agistment. This Fees Notice is always subject to change.

4. PROPRIETOR'S ADDITIONAL RENUMERATION AND GRATUITIES

1. If the Horse being an Entire, is sold or retired to stud whilst being trained by the Proprietor, or within 3 months of ceasing to be trained by the proprietor:
 - a) An additional Fee, being an amount equal to 10% (plus GST) of the sale price or value (excluding GST) of the Horse; and
 - b) Two (2) transferable lifetime service rights which will entitle the holders of such rights to nominate a mare to be provided with a stud service by the Horse during each stud season that the Horse is used to provide stud services commercially, free of any service fee.
2. If the Horse, being other than an Entire to which the above applies, is sold while being trained by the proprietor or within 3 months after ceasing to be trained by the Proprietor, an additional fee being an amount equal to 10% (plus GST) of the sale price (excluding GST) if sold privately or at public auction.
3. The entitlements of the Proprietor to the additional remuneration set out in paragraphs 1 and 2, will also apply to the sale of an interest or share in the Horse.
4. A 3% fee from all races won outside of NSW and ACT will be charged to the owner/s, to be allocated to the Stable Staff Prize Money Fund.
 - a) In NSW and ACT, there is a mandatory deduction by the Principal Racing Authority (See section 3 – Mandatory Allocation Of Prize Money Under the Rules of Racing.)

5. FINANCIAL FEES/CHARGES AND TERMS AND CONDITIONS

1. All Owners will be required to set up a Direct Debit for payments of invoices unless prior arrangements have been made with the Proprietor.
2. Interest will be charged at the rate of 2% on all overdue accounts.
3. Invoices are due within 14 days of the invoice date. Interest as in paragraph 2 will be charged if accounts are not settled by this date.
